

Softworkbench.SPGenerator .NET Licensing Agreement

IMPORTANT: PLEASE READ THE FOLLOWING CAREFULLY.

THE FOLLOWING IS A SOFTWARE LICENSE RELATED TO YOUR USE OF THE SOFTWORKBENCH, Inc. SPGENERATOR AND RELATED DOCUMENTATION ("SOFTWARE PRODUCT"). BY READING THIS DOCUMENT AND USING "SOFTWARE PRODUCT", YOU ARE CONSENTING TO BE BOUND BY THIS LICENSE AGREEMENT, AND THE TERMS SHALL BE BINDING WITH RESPECT TO YOUR USE OF THE LICENSED SOFTWARE.

- You must purchase a license for each developer involved in the use of SPGenerator to generate stored procedures. For example, if you have 5 developers using SPGenerator in your team you must purchase 5 licenses

License Agreement

This license agreement ("AGREEMENT") is a legal agreement between you (either an individual or a single entity) and Softworkbench, Inc. ("softworkbench.com") for the software product identified above ("SOFTWARE PRODUCT"), which includes the computer software and any associated media, printed materials, and "online" or electronic documentation ("PRODUCT COMPONENTS") distributed together under the product name shown above. The SOFTWARE PRODUCT also includes any updates and supplements to the original SOFTWARE PRODUCT provided to you by softworkbench.com. Any software provided along with the SOFTWARE PRODUCT that is associated with a separate end-user license agreement is licensed to you under the terms of that license agreement. By purchasing, installing, copying, downloading, executing, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this AGREEMENT. If you do not agree to the terms of this AGREEMENT, do not install or use the SOFTWARE PRODUCT.

1. Grant Of License

This AGREEMENT grants you the following rights provided that you comply with all terms and conditions of this AGREEMENT:

- 1.1. *"Licensed" Software.* If you have purchased or otherwise legally obtained a license for the SOFTWARE PRODUCT (i.e., obtained from softworkbench.com, its authorized agents or partners a printed or electronic license certificate containing a valid product key, and authorizing you to use or distribute the SOFTWARE PRODUCT) the SOFTWARE PRODUCT is considered "Licensed

Software” (and you are considered a “LICENSEE”) and you are granted the following rights:

- Licensors grants to you the right to use one copy of the Software Product on a single computer. You may load one copy into permanent memory of one computer and may use that copy, or the enclosed CD, only on that same computer.
- You may also store or install a copy of the SOFTWARE PRODUCT on a storage device, such as a network server, used only to install or run the SOFTWARE PRODUCT on your other computers over an internal network; however, you must acquire and dedicate a distinct license for each developer using the SOFTWARE PRODUCT from the storage device. Any given license for the SOFTWARE PRODUCT may not be shared or used concurrently or otherwise on different computers or by different developers in a given organization.

The stored procedures generated by SOFTWARE PRODUCT may not be distributed with your database server unless appropriate license(s) have been obtained as described in 1.1 above.

1.3. **RIGHTS IN LICENSED SOFTWARE.** You acknowledge that the Licensed Software and any copies, regardless of the form or media in which the original or copies may exist, are the sole and exclusive property of Softworkbench, Inc.; by accepting this License, you do not become the owner of the Licensed Software recorded on the media. You further acknowledge that the Licensed Software, including the code, logic and structure of the Licensed Software, contain valuable trade secrets belonging to softworkbench.com. You agree to secure and protect the Licensed Software consistent with the maintenance of Softworkbench's rights in the Licensed Software, as set forth in this License. softworkbench.com reserves all rights not expressly granted.

2. Description of Other Rights and Limitations.

2.1. *Limitations on Reverse Engineering, Decompilation, and Disassembly.* You may not reverse engineer, decompile, disassemble, or modify the SOFTWARE PRODUCT, except and only to the extent that such activity is expressly permitted by applicable law notwithstanding this limitation.

2.2. *Rental.* You may not rent, lease, or lend the SOFTWARE PRODUCT.

2.3. *Support Services.* softworkbench.com may provide you with support services related to the SOFTWARE PRODUCT ("SUPPORT SERVICES"). 2.5. *Software Transfer.* The initial LICENSEE of the SOFTWARE PRODUCT may make a one-time permanent transfer of this AGREEMENT and SOFTWARE PRODUCT only directly to an end user, provided that the LICENSEE has not distributed the SOFTWARE PRODUCT as part of a CLIENT APPLICATION.
